Cllr Pennington did ask the committee to look at the serious flooding problem but the committee accepted the evidence put forward by the Environment Agency. Mr Lake was also unable to contact the Planning Officer Mr L Andrews, for a two week period after which time it was to late to put in an appeal. Cllr Pennington is to look into this issue.

i. Frithelstock Wind Turbine policy, it was decided to develop a wind turbine policy in direct response to the open meeting held in the parish, it was felt to be unique, the government has given Parish Council powers so Frithelstock has developed this policy. It was proposed by Mr A Heard and seconded by Mr M Baker and was passed unanimously all in favour.
