Note:

1. The margin on individual events may appear low because the margin on the bar (where there was a pay-bar) is shown under the separate heading of Bar (as it is impractical to do an accurate stock-take after each event).

2. At 31 March 2012 the value of Bar stock amounted to \pounds 479 (2011 : \pounds 365) and therefore, adjusting for these figures, the margin on the bar sales (after the cost of licences etc) was approximately 48% (2010 : 53%.)

3. A £100 donation towards the cost of the Royal Wedding Party from the Parish Council was received in the previous financial year and is therefore not reflected in the above receipts.

4. In addition to the balance at bank shown as the Accumulated Fund there was a cash float in hand of £167.
